- A. BB10 is intended to be a 3/8" thick 48"X96" sheet PVC finish with 4/4x4 PVC trim battens. SS10 is a fibercement shiplap finish, there is no shingle finish for siding. All fibercement products should be provided with a factory painted finish.
- Q. Drawing A1.03 indicates Hardie Trim at windows, drawing A5.00 indicates Fypon at window head detail. If Hardie Trim is required for all windows, building corner, and overhead door trim, please clarify size and thickness of Hardie Trim at each location.
- A. A 4/4X4 Hardie Trim fibercement casing is required at all windows and doors. Fypon 6" classic crossheads are to be provided. Additionally 4/4X4 Hardie Trim shall be provided at corners and 4/4X6 Hardie Trim shall be provided at overhead door trim.
