Questions & Answers:

1. Note #1 on "General Demolition Notes at Area of Work Typ." at the bottom of the demolition drawings, directs us to Drawing# A-002 which I do not believe is in the set. Please clarify.

Answer: This should be revised to; "For additional general notes refer to sheet A-001"

2. The bid documents do not indicate flooring removal and replacement anywhere except in the bathrooms being renovated. Please confirm.

Answer: Correct, the contractor should also note that the floor should be patched where required per demolition of existing partitions in each tenant space. Please review the summary of work in Section 00050 for additional information as the bidders are not bidding on all work shown on the drawings.

3. Note 5 in "General Demolition Notes at Areas of Work Typ." located at bottom right of demolition drawings - "Remove all obsolete and abandoned piping and cabling" - is for removal of duct, pipe, control and electrical wire, etc. called out to be removed in the HVAC and electrical drawings. Please confirm.

Answer: Refer to mechanical, electrical, and plumbing bid documents for clarification on utility removal. Any additional piping or cabling that is obsolete during demolition should be removed in addition. Please review the summary of work in Section 00050 for additional information as the bidders are not bidding on all work shown on the drawings.

4. Painting - Will only the new replaced/installed gypsum walls be painted. Will they match existing walls. If existing walls are to be painted, will they need be sanded down and prepared for painting. Please clarify extent of wall painting.

Answer: This is correct per the County's intent, paint should match the existing walls. If existing walls are required to be painted, sanding would also be required. Please review the summary of work in Section 00050 for additional information as the bidders are not bidding on all work shown on the drawings.

5. Will workers in areas being renovated be temporariy relocated while renovation takes place in their work area. Simultaneous activities by various trades, dust, noise, etc. will make for an uncomfortable work environment. Please clarify.

Answer: Please refer to Section 015000 - Temporary Facilities and Controls of the specifications. Temporary partitions will be required to section off work for dust and noise control. The work will happen in phases and employees will be moved prior to the start of work. Please review the summary of work in Section 00050 for additional information as the bidders are not bidding on all work shown on the drawings.
