Site Fence Requirement

The "entire site" fence is required and to be the responsibility of the General Contractor of the SITE WORK project. It is expected that this fence will remain up for the duration of both the Site Work and Building construction projects.

Construction Trailer Requirement

A construction trailer is to be provided by the General Contractor of the BUILDING project.

PLA or Prevailing Rate

The "Site Work" project and the "Building" project do not have a Project Labor Agreement (PLA). This project shall adhere to the New Jersey Prevailing Wage Act (N.J.S.A. 34:11-56.25 et seq.)

Holding Cells

Holding cells shown on the building plan in the arrest processing area are for coordination and representation only. The holding cells are considered "furniture" and will be provided by others.

Hiring Requirements/Wage Rates

Please reference Specification section C with associated forms.

Questions Received:

1 of 1 – The specs have no clear BMS/HVAC control spec. There is mention of meeting sequences but there is no basis of design or list of acceptable manufacturers that I can find. Please confirm HVAC Controls Manufacturers or a basis of design.

The individual sequence of operations on M5.0 are to be met by the standalone packaged equipment control boards. A sampling of equipment manufacturers are included in the individual specification sections. All rooftop units are to be provided with a bacNET card for potential future integration.






