The Bidder shall submit these executed Responsible Contractor and Subcontractor Policy Certifications with his bid. Fallure to submit said executed Responsible Contractor and Subcontractor Policy Certifications with his bid is a material deviation and shall result in rejection of the bid.

All other Subcontractors hired by either 1) the General Contractor or 2) the Subcontractors who are required to be listed by operation of N.J.S.A. 40A:11-16 shall complete a Responsible Contractor and Subcontractor Policy Certification and submit it to the General Contractor before providing any work on the Project. The General Contractor shall have the responsibility to collect the Responsible Contractor and Subcontractor Policy Certifications and to submit them to the Burlington County Purchasing Agent, 49 Rancocas Road, Mount Holly, New Jersey 08060. Failure of the General Contractor to submit each Certification to the Purchasing Agent within ten days of receipt will be subject the General Contractor to a penalty of five hundred dollars (\$500.00). The Apprenticeship Program in which my firm participates meets the following criteria:

- The program has graduated at least one (1) enrollee in each of the past three years. If the Program has not been in existence for three years, this requirement shall not apply until the Program has been in existence for three years. At that time, compliance with this criteria is required.
- 2) The program has graduated at least seventy-five (75) percent of program enrollees in each of the past three years.*
- * Graduation rates for any particular year shall be calculated based on the number of enrollees who graduated in a given year divided by the total number of enrollees (and former enrollees) who could have been eligible to graduate in that year had they remained enrolled and timely completed the program. The term "total number of enrollees" shall be computed by counting the total number of persons enrolled in approved Apprenticeship Programs for each separate trade or craft approved by the State of New Jersey. For example, the total number of enrollees in the electrical trade would consist of all persons currently enrolled in an approved Apprenticeship Program for electricians in the State of New Jersey. If the New Jersey based trade or craft, conducts education classes outside the State, those attendees shall count as enrollees for purposes of this subparagraph. Enrollees who withdraw for reasons of military service, residence relocation, death, sickness, or hardship as approved by the teaching staff shall not be counted as enrollees for the purposes of calculating the graduation rate.
