1.0 RFI

- a. The following question(s) were received during the walk thru and via email and are still applicable to this project:
 - 1. For bidding purposes, we assuming the bottom of the existing footings to be 3' below grade (typical construction). Please advise if we should figure on another depth.

Answer: Based on the available existing drawings from 1976, the existing grade appears to be at roughly elevation 97.65'. The existing basement elevation is approximately 91.74', and the existing first floor at +/-104.18'. The new foundations are indicated between elevations 91.00' and 95.00' This should place them essentially on top of the adjacent existing foundations. From the existing grade, the new foundations should be down approximately 2'-8" to 6'-8" below.

2. The front entrance will need to remain closed through the duration of the project. If the contractor is required to facilitate any temporary access at another location, please provide details.

Answer: Temporary access will be provided by the Library staff around to the rear of the Library building. Directional access signage will also be provided prior to construction by the Library staff.

- Please specify the plan and contractor requirements to maintain library access for pedestrians during the construction period.
 Answer: See answer to #2.
- 4. Please specify the plan and contractor requirements to maintain ADA access during the construction period.

Answer: Temporary ADA access will be provided by the Library staff around to the rear of the Library building. ADA directional access signage will also be provided prior to construction by the Library staff.

5. At some point in time during the phasing without providing ADA access the ADA access will not be available to the building.
